

INTERNATIONAL UNDERGRADUATE FINANCIAL CERTIFICATION FORM

Under U.S. government regulations, any student who will hold F-1 or J-1 status in the U.S. or any student in F-1 or J-1 status transferring from one academic institution to another must provide documentation of the availability of sufficient funding to meet all anticipated expenses. A Bachelor's degree typically takes 4 years to complete. Below is an affidavit of support to be completed by you or your parent/sponsor. A **certified, original bank statement or bank letter** demonstrating sufficient funds must accompany this application.
